#### Overview

Providence Preparatory Charter School ("PVD Prep") is a public charter school serving 252 students in grades five through eight. PVD Prep is adding 63 students in the 2023-2024 school year and is seeking a vendor ("consultant") who can support the school principal and all teachers in mastering high engagement teaching strategies. The consultant should have five or more years of experience as a successful school leader of a high performing urban charter school. The consultant should be fluent in coaching teachers in the concrete actions and micro-skills that lead to measurable student achievement, including the skills outlined in Doug Lemov's <u>Teach Like a Champion</u> taxonomy and Paul Bambrick-Santoyo's <u>Get Better Faster</u>. The consultant will primarily work with PVD Prep's principal in designing and delivering professional development sessions.
